

ANNEX 2 - PROGRAMME OUTPUT AND RESULT INDICATORS

1. Introduction

This annex presents the definitions and programme specifications of output and results indicators used in the Interreg CENTRAL EUROPE (CE) Programme. The definitions and numbering are based on the European Commission's staff working document "Performance, monitoring and evaluation of the European Regional Development Fund, the Cohesion Fund and the Just Transition Fund in 2021-2027" (SWD(2021) 198 final).

At the application stage, each project needs to select the relevant indicators (output and related result indicators) and include a realistic quantification of its targets in the application form. During the implementation of the project, the progress and final achievement of these targets have to be reported through periodic joint activity reports. It is therefore of outmost importance for applicants and beneficiaries to understand the meaning of indicators and how their achievement shall be counted. 2. Output indicators

RCO 83 - Strategies and action plans jointly developed

Indicator code	RCO83
Indicator name	Strategies and action plans jointly developed
Measurement unit	Strategy/action plan
Type of indicator	Output
Definition and concepts	The indicator counts the number of joint strategies or action plans developed by supported projects. A jointly developed strategy aims at establishing a targeted way to achieve a goal-oriented process in a specific domain. An action plan translates an existing jointly developed strategy into actions.
	The joint development of a strategy or action plan implies the involvement of organisations from at least two participating countries in the drafting process such strategy or action plan.
Time of measurement for achievement	Upon project finalisation
Specifications	This indicator counts solely jointly developed strategies or action plans. Strategies or action plans developed by organisations from only one country should not be counted under this indicator. If, however, organisations from two or more participating countries were involved in the development (e.g. in a codesign or co-creation process, including peer reviews) of a strategy or action plan focussing only on one territory within one country, such strategy or action plan would still fulfil the requirement of "joint development" and can therefore be counted under this indicator.
	The uptake of strategies or action plans should be reflected in the result indicator RCR 79 (see below).

RCO 84 - Pilot actions developed jointly and implemented in projects

Indicator code	RCO84
Indicator name	Pilot actions developed jointly and implemented in projects
Measurement unit	Pilot action
Type of indicator	Output
Definition and concepts	The indicator counts the number of pilot actions developed jointly and implemented by supported projects. The scope of a jointly developed pilot action could be to test new procedures, instruments or tools through experimentation or demonstration of practices.
	In order to be counted under this indicator both the following conditions shall be met:
	- the pilot action needs not only to be developed, but also implemented within the project;
	- the implementation of the pilot action should be finalised by the end of the project.
	This indicator implies the involvement of organisations from at least two participating countries in the pilot action development and implementation.
Time of measurement for achievement	Upon project finalisation
Specifications	Pilot actions developed by organisations from only one country should not be counted under this indicator. If, however organisations from two or more participating countries were involved in the development and implementation (e.g. in a co-design or co-creation process, including peer reviews) of a pilot action focussing only on one territory, thus being implemented in one country only, such pilot action can still be counted under this indicator as fulfilling the necessary requirement of being "jointly developed and implemented".
	Each pilot action should lead to the development of at least one solution (see RCO116 below). The uptake of such solution(s) should be reflected in the result indicator RCR 104 (see below).
Corresponding result indicator	RCR 104 - Solutions taken up or up-scaled by organisations





RCO 87 - Organisations cooperating across borders

Indicator code	RCO87
Indicator name	Organisations cooperating across borders
Measurement unit	Organisations
Type of indicator	Output
Definition and concepts	The indicator counts the number of organisations formally cooperating in supported projects, i.e. the project partners and the associated partners participating in the project.
Time of measurement for achievement	Upon project finalisation
Specifications	This indicator has to be selected by all projects supported, counting the project partners and, if applicable, the associated partners as included in the project application form.
	The indicator should be included in the first work package.
	The continuation of the cooperation established after the project end should be reflected in the result indicator RCR 84 (see below).
Corresponding result indicator	RCR 84 - Organisations cooperating across borders after project completion





RCO 116 - Jointly developed solutions

Indicator code	RCO116
Indicator name	Jointly developed solutions
Measurement unit	Solutions
Type of indicator	Output
Definition and concepts	The indicator counts the number of jointly developed solutions from joint pilot actions implemented by supported projects. In order to be counted under the indicator, the developed solution should include indications of the actions needed for it to be taken up or to be up-scaled.
	This indicator implies the involvement of organisations from at least two participating countries in the drafting and design process of the solution.
	Solutions considered for this indicator should not have as their main focus administrative or legal frameworks.
Time of measurement for achievement	Upon project finalisation
Specifications	This indicator counts solely the number of solutions deriving from pilot actions implemented in the frame of the supported project and which have been jointly developed by organisations from at least two countries. Solutions not directly linked to a pilot action of the project or developed by organisations from only one country should not be counted under this indicator.
	If, however, organisations from two or more participating countries) were involved in the drafting and design process (e.g. in a co-design or co-creation process, including peer reviews) of a solution focussing only on one territory, thus on one country, such solution can still be included under this indicator as fulfilling the necessary requirement of being "jointly developed".
	The possible uptake of the solution should be reflected in the result indicator RCR 104 (see below).
Corresponding result indicator	RCR 104 - Solutions taken up or up-scaled by organisations





RCO 120 - Projects supporting cooperation across borders to develop urban-rural linkages

Indicator code	RCO120
Indicator name	Projects supporting cooperation across borders to develop urban-rural linkages
Measurement unit	Projects
Type of indicator	Output
Definition and concepts	The indicator counts the number of projects which aim, as a primary objective, to enhance the cooperation across borders between urban and rural areas. The urban-rural linkages developed within the project should enable a stronger urban-rural cooperation and partnership.
Time of measurement for achievement	Upon project finalisation
Specifications	This indicator applies only to the programme specific objectives (SO) 2.5 and 3.1 and should be selected by all projects targeting those SOs. Since this indicator counts the project as such, the target for this indicator should be set to "1".
	The indicator should be included in the first work package. The required cooperation of institutions of at least two participating countries is ensured by the transnational character of the partnership.
Corresponding result indicator	Not applicable





3. Result indicators

RCR 79 - Joint strategies and action plans taken up by organisations

Indicator code	RCR79
Indicator name	Joint strategies and action plans taken up by organisations
Measurement unit	Joint strategy/action plan
Type of indicator	Result
Baseline	The baseline should be set to 0
Definition and concepts	The indicator counts the number of jointly developed strategies and action plans (not individual actions - see corresponding RCO 83) which are adopted and implemented by organisations during or shortly after the project completion (i.e. by the time of submission of the last progress report, thus 3 months after the project end). At the time of reporting this indicator, the implementation of the joint strategy or action plan do not need to be completed, however it shall be effectively started. The organisations involved in the uptake may or may not be directly participating in the supported project. It is not necessary that all actions identified in a joint strategy/action plan are taken-up for such a strategy/action plan to be counted under this indicator.
	The uptake of the joint strategy or action plan needs to be documented by the adopting organisation(s), e.g. in a local/regional council decision, letters of commitment etc.
Time of measurement for achievement	Upon project finalisation or submission of the last joint activity report (3 months after the project end)
Specifications	The target (as set in the AF) and the reported value for this result indicator should be equal to or less than the value of the corresponding output indicator RCO 83 "Strategies and action plans jointly developed" (see above).
Corresponding output indicator	RCO 83 - Strategies and action plans jointly developed





RCR 84 - Organisations cooperating across borders after project completion

Indicator code	RCR84
Indicator name	Organisations cooperating across borders after project completion
Measurement unit	Organisations
Type of indicator	Result
Baseline	The baseline should be set to 0
Definition and concepts	The indicator counts the organisations (i.e. project partners and associated organisations - see corresponding RCO 87) cooperating across borders after the completion of the supported project. The cooperation concept should be based on a formal agreement to continue cooperation after the end of the supported project . The agreement should be documented by the respective organisations, e.g. decisions of local/regional council, letters of intent, memorandum of understanding, etc.
	The cooperation agreements may be established during the implementation of the project or shortly after its completion. The sustained cooperation does not have to cover the same topic as addressed by the completed project, but should be a result of the joint work within the project.
Time of measurement for achievement	Upon project finalisation or submission of the last joint activity report (3 months after the project end)
Specifications	The target (as set in the AF) and the reported value for this result indicator RCR 84 should be equal to or less than the value of the corresponding output indicator RCO 87 - "Organisations cooperating across borders" (see above).
Corresponding output indicator	RCO 87 - Organisations cooperating across borders





RCR 104 - Solutions taken up or up-scaled by organisations

Indicator code	RCR104
Indicator name	Solutions taken up or up-scaled by organisations
Measurement unit	Solutions
Type of indicator	Result
Baseline	The baseline should be set to 0
Definition and concepts	The indicator counts the number of solutions, other than legal or administrative solutions (see corresponding RCO 116), that were jointly developed by supported projects and derived from pilot actions (see RCO 84) and are taken up or up-scaled during the implementation of the project or shortly after its completion (i.e. by the time of submission of the last progress report, thus 3 months after the project end).
	The organisation(s) adopting the solutions developed by the project may or may not be a participant in the project. The uptake / up-scaling should be documented by the adopting organisation(s) through, for instance, strategies, action plans, decisions of local/regional council, letters of commitment, etc.
Time of measurement for achievement	Upon project finalisation or submission of the last joint activity report (3 months after the project end)
Specifications	The target (as set in the AF) and the reported value for this result indicator should be equal to or less than the value of the corresponding output indicator RCO 116 "Jointly developed solutions" (see above).
Corresponding output indicators	RCO 84 - Pilot actions developed jointly and implemented in projects RCO 116 - Jointly developed solutions
