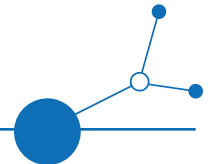

1. Interview with Alpine Pearls Members

 - Has your Pearl faced any challenges in implementing the action plan defined in the Roadmap, and if so, where? Have these been overcome (how)?
 - Does your Pearl have a specific direction or theme that guides your “policy”?
