1 Introduction and premises from the Transnational Strategy

The **Transnational Strategy for Circular Green Public Procurement (C/GPP) in Central Europe**, developed by the CE-PRINCE project, identified three overarching strategic objectives:

1. increasing the adoption of C/GPP practices,
2. developing shared C/GPP standards and criteria,
3. enhancing awareness and building capacities of public and private stakeholders in C/GPP field.

In addition, the Strategy outlines Specific Objectives addressing key challenges and opportunities to take actionable steps towards an actual implementation of C/GPP practices in the public and private sectors.

The successful implementation of the Transnational Strategy relies on **two dedicated and complementary Action Plans** – one targeting the public sector and the other the private sector. These Action Plans act as strategic roadmaps that translate the Strategy's overarching goals and specific objectives into concrete, country-level measures aimed at embedding Circular and Green Public Procurement principles into procurement policies, administrative practices, and operational decisions, for both public administrations and private entities.

This document presents the **Transnational Action Plan to improve Public Sector practices for C/GPP in Central Europe** as a key operational tool within the CE-PRINCE project to strengthen the implementation of Circular and Green Public Procurement (C/GPP) practices across Central Europe. By **targeting the public authorities**, the plan aims at reinforcing their capacity to design, implement, and monitor procurement procedures that integrate environmental and circularity criteria in public tenders to ensure the implementation of circular practices throughout the products and services' lifecycle.

In particular, this Action Plan translates the CE-PRINCE Transnational Strategy into actionable measures for Public Authorities to support the uptake of Circular and Green Public Procurement (C/GPP) across Central Europe, by addressing the following Specific Objectives of the Strategy:

- **Enhance institutional awareness, capacity, and cross-departmental coordination** to systematically integrate circularity criteria in public procurement, thus ensuring that circular procurement knowledge is embedded in long-term administrative practices.
- **Leverage on the transnational cooperation to recommend and promote the adoption of more consistent environmental and circular criteria by public entities across different governance levels and regions**, while contributing to the integration of new standardized tools in public procurement processes to facilitate the application of GPP and its alignment to EU-wide circular economy objectives.
- **Strengthen capacity-building programs** (and leverage on existing ones) for public procurement officials to improve technical expertise and confidence in implementing C/GPP criteria.

At project level, the Transnational Action Plan for the public sector provides a structured and shared framework to guide the activities that project partners will carry out in each CE-PRINCE partner country, dedicated to public administrations. It builds directly on the findings of the Initial Assessment and responds to specific national and regional needs and priorities. As such, the Plan aims to bridge the implementation gap that currently limits the role of GPP as a driver for the circular economy. It identifies specific tools of intervention to empower public authorities and create enabling conditions for enhancing the circular procurement:



- **Training and capacity building sessions:** Addressing knowledge gaps and strengthening the technical skills of public procurement officials, including the use of existing EU tools and methodologies.
- **Design and deployment of practical tools and templates:** Supporting contracting authorities in the operational integration of circular criteria into tender documentation.
- **Peer learning and exchange:** Facilitating cross-country and inter-institutional cooperation through best practice sharing, peer-to-peer exchanges, and pilot actions.
- **Strategic engagement and advocacy:** Promoting political commitment and policy alignment to mainstream C/GPP at national and regional levels.

1.1 Target Groups of the Action Plan

The primary targets of this Action Plan are:

- **Decision-makers** at the national, regional, and local levels;
- **Public procurers** and technical staff within contracting authorities;
- **Policy officers and sustainability experts** working in or with public administrations.

The Plan also addresses stakeholders involved in the governance of procurement processes, circular economy strategies, and green transition policies.

1.2 Implementation Period

All activities included in this Action Plan will be implemented between **June 2025 and November 2026**.

1.3 Methodological Approach and Reference Framework

The preparation of this Action Plan has followed a **coordinated transnational methodology**, based on common tools and structured partner inputs. In particular, the Plan relies on:

- The **Application Form** and project rationale;
- The **Initial Assessment** results and analytical framework;
- The **Transnational Strategy** for Circular GPP, which sets out shared objectives and directions in Central Europe;
- **EU-level guidance documents** (e.g., EU GPP criteria, Circular Economy Action Plan, Green Deal).

Action Plans are defined based on the specific needs and capacity of each country involved in the project. Activities are thus planned on a **country basis**, and Partners from the same country collaborate for planning and coordinating activities. This collaborative and structured process ensures that the Action Plan is both strategic and actionable, while also respecting the variety of contexts and levels of readiness across Central European countries.

The national sections of this Action Plan are structured in single **Country Datasheet** and organized as follows:

- Section on “Capacity building to match circular economy with green public procurement”: involves minimum 7 capacity building activities, including 2 meetings orienting the political willingness towards circular economy and GPP topics and 5 training sessions for Public administration representatives, targeting decision-makers and public procurers.
- Section on “Peer-to-Peer exchange and demand-supply symposia on C/GPP”: encompasses minimum 1 peer-to-peer event (public to public or private to private), 1 symposium (event between the public and the private sector) and 1 dissemination event (also open to wider participation).



- Section on “Pilot action - nurturing public authorities’ technical ability for circular GPP”: partners is a preliminary planning of national pilot actions consisting of testing an upgraded set of circular criteria into public tenders.

Although information in the country datasheets may be subject to **minor adjustments during implementation**, each Action Plan is defined in sufficient detail based on:

- The **findings of the Initial Assessment**, especially about barriers, drivers, and enabling factors for the uptake of circular and green public procurement;
- The **national/regional state of implementation of GPP** and circular policies.

Furthermore, wherever possible, actions **build upon existing tools, methodologies, or experiences developed at the national or EU level** to avoid duplication of content and promote synergies with other ongoing initiatives, projects, or networks.

Section 3 thus provides the detailed action plan of each Country introduced by brief description of the GPP status in each country and the methodological approach each partner followed for planning activities with their public administrations.



2 Overall outcomes from the National Action Plans

Based on the insights gathered from the individual country datasheets, some reflections emerge and provide a consolidated overview, at project level, of the measures and expected results defined in each country.

The economic sectors that are the primary focus of the Project (agri-food, construction, manufacturing, and tourism-related goods and services) are covered in the Action Plans of all countries. Specifically:

- The agrifood sector is covered in dedicated training sessions in Austria, Germany and Italy. In addition, it is also included in training sessions of other countries along with all other sectors.
- The construction sector is addressed primarily in Slovenia, Germany and Italy, and then included in more generic training sessions of other countries.
- The manufacturing sector is covered by specific activities in Poland and Croatia, and then invited in more generic training sessions of other countries.
- The tourism-related goods and services sector is specifically targeted by the activities planned in Croatia as well as addressed in more generic activities planned in all other countries.

Furthermore, most of the activities planned in all countries are open to wider participation to all economic sectors as topics are suitable for relevant learning and advancement towards the circular economy and the green transition in Europe.

All the Action Plans address the proper target groups expected by the Project. Specifically:

- The advocacy meetings target directors and/or representatives of administrative authorities regulating the Project key economic sectors of local, national and regional territories (e.g. department of agriculture, construction, tourism and development, urbanism and municipal services, and public procurement practices).
- The training sessions are more practical activities focusing on knowledge and skills directed at public procurers and officers of economic departments pertaining to the Project key economic sectors as well as representatives of municipalities and public companies working with economic development and public procurement;
- Peer-to-peer events for exchange and collaboration address public officers and procurers as well as decision makers of local and regional administrations and public shareholders influencing the political decision;
- Symposia target public and private representatives for effective exchanges of experiences and dialogue between public buyers and suppliers on the public procurement and economic development towards circularity;
- Dissemination events bring broad awareness and visibility of results and are open for the wider citizenry engagement, including representatives of public administrations as well as of private companies, decision makers, sector associations, academics, press corps, consumer associations and citizens.

Each country defines the topics of activities depending on national and/or regional needs related to the status of GPP in each territory and the advancement towards circularity of their economies. Nevertheless, topics can be clustered by event type and they are mostly addressed by all countries:

- Capacity building activities include topics on:



- General foundation of GPP and circular economy in EU and national legislations, shared knowledge on environmental criteria in public sectors' tenders and monitoring and evaluation of impacts;
 - Sector-specific applications of environmental criteria to specific product categories and best practices;
 - Practical skills through designing tenders with circular criteria, drafting templates, certifications and compliance with procurement law;
 - Cross-cutting themes and awareness raising on political readiness and advocacy meetings, as well as alignment of procurement with green transition strategies (e.g. Green Deal).
- Peer-to-peer exchanges are all planned among Public authorities (in this Action Plan) and they include the following topics:
 - Experience-sharing among municipalities and regions to exchange best practices on circular economy and GPP adoption, often referring to specific economic sectors (e.g. construction, food and tourism), as well as sharing joint problem-solving on legal, organizational and technical barriers.
 - Public sector collaboration for strengthening inter-municipal cooperation, aligning regional/national guidelines and political commitment.
- Symposia are conferences for promoting dialogue between public buyers and private suppliers on the following topics:
 - Exchange experiences, needs and solutions on how to integrate circular principles into procurement practices;
 - Discussions on regulatory frameworks, EU/national guidelines and innovative tools to support demand-supply cooperation;
 - Innovation and business opportunities for meeting circular criteria and accessing new procurement markets;
 - Aligning supply products and services with circular economy and green tenders' requirements
- Dissemination events are for broadening awareness, citizen engagement and visibility of results and are focused on the following topics:
 - Presenting CE-PRINCE results, GPP successful stories and pilot testing outcomes, as well as showcasing tools, guidelines and lessons learned at the end of the project;
 - Spreading knowledge on GPP and its relevance for advancing circular economy;
 - Providing practical guidance, tools and contacts for stakeholders in the field of C/GPP and encouraging them to replicate and scale-up practices across regions.

This action plan structure aims at covering a wide variety of activity types and engagement formats that effectively address the key economic sectors, target groups, and learning objectives of the Project, thereby ensuring a balanced mix of capacity building, knowledge exchange, stakeholder dialogue, and



broad dissemination. These activities will collectively contribute to achieving the objectives defined in the **Transnational Strategy** for Circular GPP and the overall goals of CE-PRINCE Project.

Section 3 digs deeper into the detailed national Action Plan of each country participating in the CE-PRINCE project.



3 Detailed National Action Plans for Public Authorities

3.1 ITALY Action Plan for Public Authorities

3.1.1 GPP status

Following the European Commission communication [EC COM\(2003\) 302](#), Italian ministries in collaboration with technical organizations (i.e., ENEA, ISPRA, ARPA, CONSIP), developed the first Action Plan for Green Public Procurement (PAN GPP) in 2008 and updated it in 2023. Since then, the use of Minimum Environmental Criteria (MEC - or CAM as Italian acronym hereby used) is mandatory in all public procurement processes. Currently, CAMs cover 21 product groups - in alignment with EU GPP and Ecolabel standards - that are constantly revised and updated, while new CAMs are under study. Despite this strong framework, challenges still exist in evaluating the broader environmental results of GPP.

Among the Italian regions, Liguria (lead partner of CE-PRINCE) has been at the forefront of GPP issues since 2007, when criteria were still voluntary, by promoting and disseminating informative/educational events on GPP and CAMs for regional public procurers and enterprises. Liguria region has already concluded two regional GPP tree-years plans (2017-2019 and 2022-2024) and it recently published the current regional GPP plan for 2025-2027. Furthermore, ongoing discussions and working groups are active at the regional institutional level.

3.1.2 Methodological approach for identifying training needs and planning activities

The Department of Environment and the Department of Economic Development at Liguria Region conducted a series of internal meetings to coordinate the organization of advocacy meetings, the capacity building activities, the peer-to-peer and demand-supply symposia events, including the identification of main topics to address in each event. In general, it was decided that the capacity-building activities should be as interactive as possible with participants, involving working groups for exchanging knowledge and experiences in order to advance concrete actions within the public administrations.

As for the organization of activities, it was agreed that the advocacy meetings would be conducted at the regional level involving policy-makers and general directors of the Region, while for the capacity building activities, it was agreed to assign the management of training sessions to an external consultancy via direct assignment.

As for the thematic issue to address during the activities, Liguria Region focused on the results of the initial assessment at the beginning of the project as well as the interviews conducted with n°5 Public Administrations for the complementary qualitative analysis. Also, the Liguria Region conducted additional one-to-one meetings with stakeholders of the Project to collect further information, needs, requests, and proposals in relation to GPP, CAM, and circular economy topics. Specifically, the contacted stakeholders were:

- 1 Associated partners: Città Metropolitana di Roma
- 5 interviewed during the initial assessment (qualitative analysis): National Park of 5 Terre, Liguria Region department of contracting authority (SUAR), Municipality of Genoa, Municipality of Celle ligure, Municipality of Badalucco



Based on the collected information, the following table summarizes the topics identified that would be most beneficial for the regional Public Administrations to address during the formative events. Such topics will be requested to the external consultancy appointed to conduct the training.

3.2 AUSTRIA Action Plan for Public Authorities

3.2.1 GPP status

The EU defines Green Public Procurement (GPP) as a process where public authorities purchase goods, services, and work with lower environmental impact across their life cycle. GPP aims to replace traditional procurement methods with greener alternatives. The European Commission offers voluntary GPP criteria for several product groups and increasingly introduces mandatory requirements in sector-specific laws. Eco-labels, such as the EU Ecolabel, are often used in technical specifications and award evaluations. Recent reforms in EU procurement emphasize non-price factors, especially sustainability, over purely cost-based decisions. Joint procurement initiatives are encouraged to promote green innovation in the market.

Austria's national action plan for sustainable procurement ([naBe-Aktionsplan](#)), launched in 2010, mandates green criteria for 16 product categories including textiles, ICT, and construction. These categories also cover cleaning services, (agri) food, and lighting products. The naBe platform supports implementation with help-desk services, events, and informative factsheets. Austria's Federal Procurement Agency (BBG) manages a centralized e-procurement platform called e-Shop with millions of listed products. Regional governments like Vorarlberg, Tyrol, and Lower Austria adopt naBe's criteria as minimum standards. Austria's efforts in sustainable procurement have gained recognition at an international level. It is widely regarded as a global leader in green public procurement practices.

3.2.2 Methodological approach for identifying training needs and planning activities

The agrifood sector is a priority for Styria due to its direct connection with public health, local economy, and environmental sustainability. There is particular potential in school catering, hospital kitchens, and municipal canteens, where regional and organic sourcing can be combined with waste reduction and circular economy measures. These initiatives will be aligned with the national naBe criteria for sustainable food procurement and supported by guidance from the naBe platform. Additionally the "BVN" (federal procurement Network) will carry out an overview of existing standards used in Styria.

The programme for Styria will focus on integrating circular economy principles into public food procurement, with particular attention to regional, seasonal, and organic sourcing. Internal workshops will be held with regional authorities and key municipalities such as Graz, Gleisdorf and Feldbach to identify current procurement practices for food and catering, assess existing capacities, and determine priority areas for improvement. These sessions will serve to map both the demand for sustainable agrifood procurement and the institutional readiness to implement it.

Then, at least seven initiatives will be carried out: **two strategic meetings** aimed at orienting and reinforcing political willingness at the regional and municipal levels, and **five capacity-building sessions** for representatives of public authorities, focusing on practical approaches to integrating regional, seasonal, and organic products into public catering, as well as methods for aligning procurement processes with the naBe criteria and circular economy principles.

In parallel, **three major exchange formats** will be organised, drawing on existing resources and initiatives from the Climate Alliance network and other regional platforms and involving actors from the



federal procurement Network, Department of agriculture, municipalities, local food suppliers, and Clusters:

- **One peer-to-peer event** enabling municipalities and public institutions to share experiences and best practices in sustainable food procurement;
- **One symposium** aimed at fostering dialogue between public buyers and local agrifood suppliers;
- **One dissemination event** to communicate outcomes and promote successful models to a broader audience, including the private sector.

To ensure high-quality and practical training delivery, an external consultant or specialised organisation will be contracted to design and implement the workshops and to find a structure to promote green public procurement and local, regions food in Styria.

This facilitation will mirror the interactive, hands-on approach used, focusing on real case studies, tender examples, and practical exercises. The sessions will address the full procurement cycle in the agrifood sector - from defining sustainability criteria in tender specifications, to verifying compliance during contract execution, to evaluating environmental and social impacts.

3.3 GERMANY - Action Plan for Public Authorities

3.3.1 GPP status

Sustainable public procurement in Germany is shaped by a multi-level legal framework that integrates European Union directives, federal legislation, and state-level (Federal States) regulations. Since the transposition of the 2014 EU Procurement Directives, federal laws such as the Act against Restraints of Competition (GWB - "Gesetz gegen Wettbewerbsbeschränkungen"), the Regulation on the Award of Public Contracts (VgV - "Vergabeverordnung"), and sector-specific rules like the Sub-threshold Procurement Regulation (UVgO - "Unterschwelvenvergabeordnung"), the Procurement and Contract Procedures for Services (VOL/A - "Vergabe- und Vertragsordnung für Leistungen") and the Procurement and Contract Procedures for Construction Works (VOB/A - "Vergabe- und Vertragsordnung für Bauleistungen") form the legal basis for environmentally and socially responsible procurement.

German procurement law mandates consideration of life-cycle costs, energy efficiency, CO₂ emissions, and resource conservation, particularly through instruments like the Circular Economy Act (KrWG - "Kreislaufwirtschaftsgesetz") and the Federal Climate Protection Act ("Bundes-Klimaschutzgesetz"). These laws enable contracting authorities to give preference to products and services with superior environmental performance, provided these criteria are transparent, non-discriminatory, and relevant to the contract. Moreover, environmental procurement applies across sectors: while VOB/A governs construction tenders, and UVgO or VOL/A apply to supplies and services (depending on implementation at the state level), all frameworks permit the inclusion of sustainability criteria—provided legal proportionality and relevance are ensured.

Due to Germany's federal structure, the 16 Federal States have the authority to adopt their own procurement laws for contracts below EU thresholds. As a result, sustainability requirements vary across states: some Federal States, such as Berlin, Bremen or North Rhine-Westphalia, have enacted progressive procurement acts mandating compliance with environmental and fair-trade standards; others apply more general rules without binding sustainability obligations. In parallel, municipalities as the largest group of contracting authorities possess significant leeway within the legal framework. They can adopt their own procurement guidelines, specify award criteria (e.g., environmental labels, recyclability, CO₂ performance), and introduce weighting schemes that prioritize sustainability over price alone. Local procurement statutes or administrative orders often complement state-level regulations. The federal system thus allows states and municipalities to tailor and expand sustainability requirements. This decentralization offers opportunities for innovation and leadership at subnational levels but also results in considerable variation in practice across the country.

3.3.2 Methodological approach for identifying training needs and planning activities

The development of the event concept is based on ABW's established connections with its public stakeholders, including the City of Leipzig and the surrounding districts of Leipzig, Northern Saxony, and Central Saxony. These relationships provide access to key regional actors and institutional support. The methodological foundation draws on existing networks and initiatives, such as the regional Competence Centre for Sustainable Procurement and the model region within the German Federal Government's Circular Rural Regions programme. Both initiatives are already engaged in implementing sector- and theme-specific formats and maintain strong ties to relevant stakeholders and expert communities.



ABW will implement the event formats in close cooperation with these actors, either by organising its own events with their involvement or by contributing to their existing programme calendars. This collaborative approach ensures relevance, continuity, and high levels of participation. A distinctive element of the methodology is the integration of a European perspective, particularly through insights and findings from the CE-PRINCE project. This dimension is currently underrepresented in the region and adds significant value to the discourse. All key economic sectors are addressed with specific formats for Agrifood and Construction, the main sectors selected by ABW in the earlier stage of the project.

To ensure methodological transferability, the approach foresees the development of comparable formats across various sectors. In general, events will be conducted online in order to include stakeholders from across the entire federal state. When in-person formats are pursued, they will be attached to events of partner organisations, allowing ABW to benefit from existing venues and networks, and to maximise outreach and resource efficiency.

3.4 SLOVENIA - Action Plan for Public Authorities

3.4.1 GPP status

Slovenia's Green Public Procurement (GPP) framework is anchored in the Decree on Green Public Procurement (Uredba o zelenem javnem naročanju), accessible via the [national legal portal](#). The initial National Action Plan on GPP (including the Policy Statement) was adopted on 21 May 2009, forming the foundation for mandatory environmental criteria in procurement procedures. The current decree has been iteratively updated through several amendments to strengthen alignment with EU policies on circular economy and decarbonisation of the built environment:

- Official Gazette RS, No. 51/17 (19 September 2017) - introduction of core mandatory GPP obligations;
- No. 64/19 (25 October 2019) - expansion of product groups and criteria;
- No. 121/21 (23 July 2021) - updates on technical specifications and verification mechanisms;
- No. 132/23 (22 December 2023) - integration of Level(s) sustainable construction indicators;
- No. 43/25 (17 June 2025) - comprehensive revision, entering into force on 17 September 2025, extending GPP obligations to additional building categories (e.g., healthcare and residential facilities), reinforcing near zero-energy standards (sNES) for design and construction, and expanding the mandatory use of timber in several new building types (CC-SI 111, 112, 121).

So, Slovenia is in the process of significantly strengthening its GPP framework, with the new Decree on Green Public Procurement (ZeJN) formally adopted and entering into force on 17 September 2025. The updated decree expands the scope of mandatory sustainability requirements to include reconstruction and change-of-use projects, as well as the purchase or lease of buildings involving construction works requiring building permits. Additionally, nearly zero-energy building standards (sNES) are now mandatory, alongside obligatory minimum wood share targets in public buildings, which now also apply to healthcare, residential (CC-SI 111, 112), and hospitality (CC-SI 121) buildings.

These updates align Slovenia's GPP with the EU Public Procurement Directive (2014/24/EU) and circular economy targets, promoting life-cycle approaches, the use of eco-labels, and reduced carbon footprints in public tenders. Building on the CE-PRINCE baseline assessment, Slovenia's GPP implementation remains uneven across sectors due to legal uncertainties and a historically strong focus on lowest-price criteria. The integration of circular economy (CE) principles is still emerging, but the new ZeJN decree, combined with planned training and pilot activities, will act as a key accelerator for embedding CE practices into national procurement.

In Slovenia, GPP criteria remain compulsory for 22 product and service groups, covering electricity, food and catering, construction works (buildings and roads), furniture, textiles, vehicles, and more. These criteria are largely harmonised with EU GPP guidance and regularly revised, with the most recent guidelines update completed in February 2020. Slovenia applies Level(s) indicators for sustainable construction as part of its national framework, linking circularity goals, carbon reduction, and sustainable financing to practical procurement standards. Monitoring is performed annually via the national public procurement portal and statistical reports, tracking tenders, contracts, and compliance across all public entities, including national and local authorities.



3.4.2 Methodological approach for identifying training needs and planning activities

The Chamber of Commerce and Industry of Slovenia (CCIS), through its Division for Construction and Building Materials Industry (CCBMIS), applies a multi-step methodology to identify training needs and design CE-PRINCE capacity-building activities for Slovenian public authorities and enterprises. The methodology builds on stakeholder data gathered via field interviews, surveys, and desk research (completed December 2024) and aligns with national priorities, the newly adopted Decree on Green Public Procurement (ZeJN, adopted 17 June 2025 and entering into force 17 September 2025), EU GPP guidance, and the CE-PRINCE Transnational Strategy (adopted May 2025).

The construction sector serves as the primary economic focus due to its strategic weight in Slovenia's GDP, its regulatory exposure to GPP obligations, and its pivotal role in advancing circular economy (CE) principles.

The methodology includes:

1. **Stakeholder segmentation** - Mapping and grouping public authorities (ministries, municipalities, SDH, DSU), sectoral agencies, and businesses (large enterprises and SMEs) according to sectoral relevance, with construction and related value chains as the lead sector.
2. **Gap analysis** - Evaluating the current level of knowledge and implementation of GPP and CE principles across contracting authorities and suppliers, compared to the enhanced requirements of the September 2025 ZeJN decree, EU GPP benchmarks, and CE-aligned best practices (e.g., use of Level(s) indicators, circularity criteria).
3. **Training programme design** - Developing tailored capacity-building modules for:
 - Public authorities - focused on legal clarity, early market engagement, integration of circular and Level(s)-based criteria, and practical use of tools such as the Dutch SPP Tool to simplify tender preparation and evaluation.
 - Enterprises (with a priority on construction and materials SMEs) - centred on product and process transformation, innovation adoption, and uptake of international and European standards (ISO 14001, EMAS, EPD, Cradle to Cradle, WELL Building Standards, Level(s), STAR-rated schemes) to ensure credibility and competitiveness in public tenders.
4. **Action planning and piloting** - Under CE-PRINCE project, CCIS will co-develop sector-specific action plans and initiate pilot testing for construction-related GPP tenders. Activities will run from **autumn 2025 through winter 2026**, combining hybrid workshops, peer-to-peer exchanges, supplier engagement sessions, and pilot tenders with embedded circular criteria to build market readiness.

3.5 HUNGARY - Action Plan for Public Authorities

3.5.1 GPP status

Hungary has progressively integrated Green Public Procurement (GPP) into its national environmental and procurement policies. The Hungarian Ministry of Energy, in collaboration with the Ministry of Public Administration and relevant technical institutions such as the National Directorate General for Environment and the Herman Ottó Institute, has developed national guidance and support tools for GPP implementation. Although Hungary has not yet adopted a legally binding National Action Plan (NAP) for GPP, several strategic documents and sectoral policies emphasize the importance of sustainability in public procurement.

Hungary follows the EU GPP criteria and incorporates them into voluntary national guidelines aimed at enhancing the uptake of environmental considerations in tenders. Efforts have been made to promote the use of green criteria in specific sectors such as construction, energy-efficient office equipment, and cleaning services, with reference to EU Ecolabel and GPP standards. However, the application of green criteria is still largely non-mandatory, and implementation varies significantly across public authorities.

At the regional level, several pilot projects and training programs have been initiated, particularly under EU co-funded projects like LIFE and Interreg. Municipalities such as Budapest and Szeged have shown leadership by integrating GPP into local procurement strategies. Capacity building activities, awareness-raising events, and workshops for contracting authorities have also been regularly organized by NGOs and environmental organizations, including the Hungarian Cleaner Production Centre.

While Hungary continues to make progress, key challenges remain, particularly in mainstreaming GPP across all procurement levels and improving monitoring systems to evaluate its environmental and economic impacts. Ongoing dialogue and cooperation among ministries, local authorities, and civil society are essential to further embed GPP practices and move towards a more sustainable procurement culture.

3.5.2 Methodological approach for identifying training needs and planning activities

The South Transdanubian Regional Innovation Agency (STRIA) conducted a series of internal meetings to coordinate the organization of advocacy meetings and the capacity building activities, and the peer-to-peer and demand-supply symposia events, including the most precise definition of topics possible for all events.

Based on STRIA previous experiences and public administration sector busy schedule, it was decided that the advocacy meetings and the capacity-building activities should be organised online and each session would be recorded and shared with participants, involving stakeholder groups for exchanging knowledge and experiences in order to satisfy the public administration sector real needs in regard of GPP/CPP as well as the peer-to-peer and demand-supply symposia event.

As for the organization of activities, it was agreed that the advocacy meetings would be conducted at national level involving policy-makers and general directors of the South Transdanubian region, while for the capacity building activities, it was agreed to propose reputable lecturers for the workshops upon invitation depending on the activities topics.

As for the thematic issue to address during the activities, STRIA took into consideration the experiences of the interviews, and surveys and its results of the initial assessment with the Public



Administrations actors for the complementary qualitative analysis. As mentioned, STRIA conducted further discussions with the associated partner, stakeholder groups, and supporting organisations to have further information, needs, requests, and proposals in relation to GPP, CAM, and circular economy topics.

Based on the gathered information and requests, all events will be open for the general public and for all sectors ensuring the opportunity to learn for each interested party and raise awareness for the circular economy in Central Europe.

3.6 CROATIA - Action Plan for Public Authorities

3.6.1 GPP status

Croatia's Green Public Procurement (GPP) framework was established in response to EU Directive 2014/24/EU, with the National Action Plan for GPP (NAP GPP) adopted in 2015 and extended through 2020, targeting 50% of public procurement to incorporate green criteria by 2020. The 2024 Government Decision on GPP Implementation (Official Gazette 137/24, effective January 1, 2025) made criteria mandatory for central procurement "where feasible," covering 10 priority product groups like paper, energy, and IT, aligned with EU standards to promote circular economy practices such as waste reduction and low-carbon sourcing. Despite this progress, uptake remains low at ~10% of contracts in 2019 (per One Planet Network reports), with challenges including voluntary implementation in smaller entities, limited training for procurers, and data gaps in monitoring, as highlighted in the 2025 updated National Energy and Climate Plan (NECP 2021-2030). Dubrovnik, GPP adoption is nascent but tied to the city's tourism-driven economy, where ~5% of municipal tenders in 2024 included green criteria, primarily in energy-efficient lighting and waste management for public spaces. As a UNESCO-protected site, Dubrovnik's Respect the City initiative (a sustainable tourism plan) complements the national mandate, emphasizing eco-friendly procurement to balance 1.8 million annual visitors with heritage preservation. Local reflection reveals opportunities in tourism sectors like transport and hospitality, but barriers such as small supplier pools and budget constraints persist; CE-PRINCE's focus on capacity-building workshops can bridge these gaps, fostering GPP integration to support the county's 3.2% projected GDP growth in 2025.

3.6.2 Methodological approach for identifying training needs and planning activities

The Dubrovnik Development Agency (DURA) coordinated a series of internal workshops with the City of Dubrovnik's Administrative Departments (e.g., Culture, Tourism, Urbanism) to align advocacy meetings and capacity-building activities, alongside peer-to-peer and demand-supply symposia. Emphasis was placed on interactive formats, incorporating working groups to facilitate knowledge exchange and actionable GPP strategies among public procurers. Advocacy meetings targeted regional policymakers and directors, held in-person at Dubrovnik City Hall, while capacity-building sessions were planned for external facilitation via a public tender, ensuring expertise in circular economy and GPP. Training needs were identified using the Initial Assessment findings, which highlighted barriers like limited GPP awareness and skills in Dubrovnik's public sector, supplemented by qualitative interviews with five local stakeholders (e.g., Libertas Dubrovnik d.o.o., Dubrovnik Utility Company, Municipality of Dubrovnik, DURA procurement team, and Respect the City coordinators). Additional one-to-one discussions with CE-PRINCE partners refined priorities. Based on this, key topics were selected, focusing on tourism and transportation sectors (aligned with Action Plans for public and private enterprises), to address GPP compliance, circular procurement, and sustainable transport solutions. These will guide the external trainer's curriculum.

This approach ensures tailored, sector-specific training, leveraging existing synergies like the GPP mandate (NN 137/24) and Respect the City initiative.

3.7 POLAND - Action Plan for Public Authorities

3.7.1 GPP status

Since 2004, the public procurement system in Poland has undergone significant modernization, adapting to EU law and internal market principles. The key piece of legislation was the Public Procurement Law of 29 January 2004, which has been amended and supplemented many times with sectoral regulations (including those concerning energy efficiency, public transport and the national EMAS system). This framework enabled the inclusion of environmental criteria in tendering procedures, laying the foundations for the development of Green Public Procurement (GPP). Currently, the Public Procurement Law of 2019 is in force, having entered into force on 1 January 2021. The new regulations, adopted in September 2019, introduced significant changes aimed at facilitating the conduct of proceedings, especially in the context of EU directives.

The first National Action Plan for GPP was adopted in the mid-2000s. Its goal was to stimulate the market for environmentally friendly products and technologies by boosting demand from the public sector. The plan emphasized the use of eco-labels, environmental management systems, and life-cycle costing (LCC). Subsequent plans expanded the range of recommended areas - from office equipment to construction, transport, and electromobility.

For a long time, however, GPP implementation in Poland remained voluntary and depended heavily on the initiative of individual contracting authorities. In practice, the lowest-price criterion prevailed, and references to environmental aspects were rare. According to the Public Procurement Office's (PPO) report for 2020, only about 1% of contracts included environmental or innovative criteria, although their value represented around 7% of the procurement market.

Recent data, however, shows gradual improvement. According to the Central Statistical Office's (GUS) "Green Economy Indicators in Poland 2024," the value of green public procurement in 2023 reached PLN 11.9 billion (excl. VAT), representing 4.3% of the total procurement market. Compared to 2016, this was an eleven-fold increase in value and a six-fold increase in the number of contracts. On the other hand, 2023 also brought setbacks - although the number of GPP procedures rose by 22%, their total value dropped by 30.6% year-on-year. This shows that while the overall trend is upward, GPP implementation in Poland is still inconsistent and unstable.

The Public Procurement Office (PPO / UZP - Urząd Zamówień Publicznych) plays a key role in the development of GPP. It operates at the government level. The mission of the Public Procurement Office is to ensure that contractors have access to public procurement on non-discriminatory terms and to ensure the transparency and efficiency of procedures. The central government body responsible for procurement matters is the President of the Office. The President of the Office is supervised by the Minister responsible for the economy. In addition to monitoring and reporting statistics, it conducts extensive educational and promotional activities. The Public Procurement Office website features numerous publications, such as examples of environmental clauses, guidelines on the circular economy in procurement, collections of good practices, studies on eco-labels, an LCC cost repository, guides on GPP regulations, and analyses of construction investments with recommendations for reducing environmental impact.

Two decades after Poland's EU accession, Green Public Procurement has become an important element of procurement policy, though its market share remains limited. The legal and strategic framework is in place, and PPO provides tools and expertise. The main challenge is the widespread and consistent application of environmental criteria across contracting authorities, and overcoming the entrenched



dominance of the lowest-price approach. EU policies and subsequent national action plans indicate, however, that the role of GPP in Poland will continue to grow in the coming years, both as an environmental policy instrument and as a driver of market innovation.

3.7.2 Methodological approach for identifying training needs and planning activities

The activities planned by ARMSA in Mazovia are focused on all sectors indicated in the project, i.e. Agrifood, Construction, Manufacturing, and tourism-related goods and services. The activities will be inaugurated by a symposium, which will take place during a regional event—The Masovia Development Forum. The Forum is a gathering place for representatives of local government units, local authorities, employees of municipalities and districts, representatives of Business Environment Institutions, representatives of schools and universities, representatives of regional companies. This activity will take the form of a debate, in which a project expert will participate - a person with many years of experience in public procurement, including GPP. During this symposium, we will present criteria in public sector tenders and exchange knowledge and experience in the area of Green Public Procurement implementation. This will be followed by a face-to-face meeting with representatives of local and municipal authorities, conducted by experts in the field of Public Procurement. The activity aims to interest participants—decision makers—in the introduction of Green Public Procurement criteria. In addition, on the same day, there will be individual consultations for representatives of local governments, municipalities, cities, and counties with experts, who will support decision makers in resolving doubts and problems and encourage them to apply GPP criteria.

Two meetings are planned to assess political readiness, and five capacity-building sessions with local and regional decision-makers, as described below.

In parallel, peer-to-peer and dissemination events will be held at the regional level. A peer review visit is planned to assess and exchange best practices within the pilot action. The meeting will be a key step in ensuring that the pilot action is in line with our overall objectives and will deliver tangible results in the context of green public procurement. A dissemination meeting (planned online or in person) to disseminate the GPP concepts discussed in the project, as well as the solutions implemented by the partner regions. The meeting will aim to convince participants of the benefits of implementing GPP in the daily tasks performed by local government units and public and private institutions.

A number of activities have been planned for representatives of local government units and other public institutions, aimed at developing competences in the field of GPP and C/GPP. These include:

- Training sessions (capacity-building, in-person and online)

Five training sessions will be held, dedicated to representatives of public authorities. Their main objectives will be to:

- present practical ways of integrating C/GPP principles into procurement
- procedures, inspire contracting authorities to apply environmental instruments tailored to the subject matter of the contract,
- develop competences in the environmental assessment of products and services.

- Meetings with local government representatives

Direct meetings with representatives of local and municipal authorities will be held, led by experts in the field of public procurement. The aim of these activities will be to encourage decision-makers to introduce GPP criteria by presenting:

- economic benefits (building a sustainable and resilient local economy),
- dispelling the myth that GPP equals more expensive procurement,
- opportunities for introducing innovation into local activities,



- examples of effective practical implementations.
- Individual consultations
Representatives of municipalities, counties, and cities will be able to benefit from individual consultations with public procurement experts. The consultations will be focused on practical support in implementing GPP criteria and preparing procurement documentation.
- Subregional meetings
Meetings will be organized in county cities (Siedlce, Radom, or Plock) for representatives of local governments, during which the benefits and conditions of applying C/GPP will be discussed, including:
 - current and upcoming regulations,
 - potential long-term savings,
 - image-related and social benefits,
 - examples of applying environmental criteria in practice
